Professional Standards

Friday, January 22, 2010 • 7.5 Clock Hours • Course #C4629

Class Description: An overview of business ethics and REALTOR Professional Standards, how to avoid bringing discredit to the real estate profession, the importance of principles of competence, fairness and integrity, an overview of professional standards enforcement, the difference between ethics complaints and arbitration requests, and case studies of code violations. The course also meets the 2.5 hours of required education on the code of ethics mandated by the National Association of REALTORS.

Instructor, Jan Ellingson, Burlington ABR, ABRM, CRB, CRS, GRI, ePro, Burlington: is the Immediate-Past Washington REALTORS® President, and is a past Treasurer. As a member of the Washington REALTORS® faculty she teaches the ABR, ABRM, and WCR Designation Courses, Professional Standards and Ethics, the state CORE class, and Environmental Hazards.
